A motion was made by Tony Kelley and seconded by Chad Munsey to approve the Duty Disability Application for Greg Messmer, City of Town and Country. Motion carried 6-0, Joan Jadali abstained.

A motion was made by Arby Todd and seconded by Claire West to approve the Duty Disability Application for Eric Roepke, City of Springfield. Motion carried 6-0, Tony Kelley abstained.

A motion was made by Frank Buck and seconded by Sandy Walker to appoint David Bandre as the Hearing Officer in the Paula Washam duty disability retirement petition for administrative hearing. Motion carried 7-0.

A motion was made by Arby Todd and seconded by Sandy Walker to appoint Jamie Cox as the Hearing Officer in the Robert Romey duty disability retirement petition for administrative hearing. Motion carried 7-0.

Investment Report

Marcia Beard, RVK Board Investment Consultant Team led the Board through a summary presentation of the 2023 4th Quarter Investment Performance Report.

A detailed presentation of the recommendations for setting the investment benchmarks was also presented by Marcia Beard, RVK, Inc.

A motion was made by Sandy Walker and seconded by Tony Kelley to approve setting the investment benchmarks as presented and update the Statement of Investment Policy to reflect those changes. Motion carried 7-0.

Management Report

Melissa Rackers presented the Board with recommended changes to the staff benefits plan to include transitioning broker services to TIG Advisors and moving the health insurance to a qualified high deductible healthcare plan layered with a medical expense reimbursement plan.

A motion was made by Frank Buck seconded by Sandy Walker to approve staff benefit changes as presented. Motion carried 7-0.

Melissa Rackers provided a mid-year FY 2024 Budget update.

Elizabeth Althoff gave an update of the 2024 regular legislative session where she specifically highlighted the status of LAGERS priorities bills as well as those bills that LAGERS has supported and opposed.

Andrew Sartorius provided an overview on a proposed Administrative Rule change that would modify the definition of trustees and establish election procedures. Mr. Sartorius reviewed the current rule language as well as the proposed language to be considered by the Board.

A motion was made by Sandy Walker and seconded by Tony Kelley to approve Part 1 (Changes the definition of trustees.) of the proposed board election rule changes as presented. Motion carried 7-0.

A motion was made by Sandy Walker and seconded by Tony Kelley to approve Part 2 (Establishes election procedures.) of the proposed board election rule changes as presented. Motion carried 7-0.

Closed Session
